District Parent Involvement Policy/Procedures 2011/2012

Mountain Iron-Buhl ISD 712 is committed to the goal of providing quality education for every child in this district. To this end, we want to establish partnerships with parents and with the community. Everyone gains if school and home work together to promote high achievement by our children. Neither home nor school can do the job alone. Parents play an extremely important role as children's first teachers. Their support for their children and for the school is critical to their children's success at every step along the way.

PART I. DISTRICT EXPECTATIONS

The Mountain Iron-Buhl ISD agrees to implement the following requirements:

1. Mountain Iron-Buhl ISD 712 will take the following actions to involve parents in the joint development/revision of its district parent involvement policy/procedures:

A new Title I Advisory Committee will be established yearly. Members will include: Parents of Title I students, the Title I teachers, the Elementary Principal/Superintendent. This committee will meet for the purpose of program planning and evaluation. Yearly findings will result in modifications of the plan to increase parent involvement and communication. The Parent Committee Representatives on the Title I Advisory Committee will provide continual updates to the families of Title I students.

2. Mountain Iron-Buhl ISD 712 will involve parents in the joint development of district plan, review and improvement [i.e. district plan, *section 1112*, school wide *section 1114*, and /or school improvement *section 1116*];

Parents will be notified by letter that their child qualifies for the Title I program. The Title I teacher will confer with the parent to share academic strengths/concerns to explain Title I expectations/program benefits, and set goals for the year. At the fall conference the Parent/Title I Teacher/Student Compact is reviewed and discussed. This agreement is a school and home commitment to provide the highest level of support for the child. Parent support, school attendance, and completion of home activities are vital to the child's progress thus required for the student to remain in the program. A spring parent/teacher conference will be held to discuss program achievements and future goals.

- 3. Mountain Iron-Buhl 712 will provide the necessary coordination, technical assistance, and other support to assist Title I schools in planning and implementing effective parental involvement activities to improve student academic achievement and school performance.
- 4. Mountain Iron-Buhl ISD 712 will build the schools' and parents' capacity for strong parental involvement, in order to ensure effective involvement of parents and to support a partnership among the school involved, parents, and the community to improve student academic achievement, through the following activities specifically described below:
 - A. The school district will, with the assistance of its Title I schools, provide assistance to parents of children served by the school district or school, as appropriate, in understanding topics such as the following, by undertaking the actions described in this paragraph-

 - The state and local academic assessments including alternate assessments,

District representatives will attend the annual MAASFP convention.

- B. The school district will, with the assistance of its Title I schools, provide materials and training to help parents work with their children to improve their children's academic achievement, such as literacy training and using technology, as appropriate, to foster parental involvement, by:
 - Provide pertinent Title I information in handouts to parents.
 - Provide educational computer sites.
 - Provide access to NWEA Reading levels for Title I parents.
 - Provide information for suggested educational software for parental purchase.
 - Provide access to introduce parents to Parent Portal during Open House.
- C. The school district will, with the assistance of its Title I schools and parents, educate its teachers, pupil services personnel, principals and other staff, in how to reach out to, communicate with, and work with parents as equal partners, in the value and utility of contributions of parents, and in how to implement and coordinate parent programs and build ties between parents and schools, by:
 - Provide tips and information for staff and parents to create effective homework and assignment policies.
 - Provide teachers and staff knowledge on now to access and interpret NWEA results and plan needed intervention and skill development.
 - Communicate with parents through open house, parent/teacher conferences, child study meetings, and staff meetings.
- D. The school district will coordinate and integrate parental involvement programs and activities with Head Start, Reading First, Early Reading First, Even Start, Home Instruction Programs for Preschool Youngsters, the Parents as Teachers Program, and public preschool and other programs, and conduct other activities, such as parent resource centers, that encourage and support parents in more fully participating in the education of their children, by:
 - Provide open house for Title I parents in the fall, parent/teacher conferences.
 - Provide scheduled Title I meetings during fall open house.
 - Provide opportunities for parents for hands on activities throughout the year.
 - Encourage parents to participate in Head Start or Early Childhood Family Education programs/activities throughout the year.

- E. The school district will take the following actions to ensure that Title I information related to the school and parent-programs, meetings, and other activities, is sent to the parents of participating children in an understandable and uniform format, including alternative formats upon request, and, to the extent practicable, in a language the parents can understand:
 - Provide pertinent information about the Title I program via the Ranger Newsletter.
 - Provide newspaper articles to inform public of upcoming meetings/programs.
 - Provide fall & spring parent/teacher conferences.
 - Provide advisory meetings to evaluate programs and determine what positive changes and improvements can be made in various facets of the program.
- 5. Mountain Iron-Buhl ISD 712 will take the following actions to conduct, with the involvement of parents, an annual evaluation of the content and effectiveness of this parental involvement policy in improving the quality of its Title I schools. The evaluation will include identifying barriers to greater participation by parents in parental involvement activities (with particular attention to parents who are economically disadvantaged, are disabled, have limited English proficiency, have limited literacy, or are of any racial or ethnic minority background.) The school district will use the findings of the evaluation about its parental involvement policy and activities to design strategies for more effective parental involvement, and to revise, if necessary (and with the involvement of parents) its parental involvement policies.
 - Propose to develop a survey using parental input from Title I parents, regular elementary teaching staff, special education staff, Title I staff, and administration.
 - The elementary principal/Title I director will be responsible for implementing changes if needed.
- 6. Mountain Iron-Buhl ISD 712 will involve parents in the decisions regarding how funds reserved for parental involvement activities:
 - Parents will have input during open house and parent involvement committee meetings.
